

The architect has identified the User Layer requirements, as shown in the Exhibit.

User Group	User Devices	Connection Point	Security Requirements
Accountants	Corporate- owned desktops, laptops	Internal	Should minimize user effort required to authenticate while meeting general security requirements
Executives	BYOD smartphones, tablets	Internal and External	Should minimize user effort required to authenticate while meeting general security requirements
Customers	Public kiosks	Internal	Use kiosks to access a published app hosted by a group of servers in an isolated network segment Should NOT have knowledge of Workspace Services credentials
Contractors	BYOD desktops, laptops	External	User devices must have up-to-date antivirus software installed before they can access the XenApp and XenDesktop environment. Should NOT have knowledge of Workspace Services credentials and must supply their own authentication provider

Additionally, management at the organization has identified the following general Access Layer

requirements:

A multi-factor authentication method is required for any connections to the XenApp and XenDesktop

environment originating from outside the corporate network.

External connections must be authenticated by a NetScaler Gateway virtual server located in a DMZ

network.

Internal connection traffic should NOT leave the internal corporate network.


