These errors can occur when you allocate too many channels for a backup or restore from Avamar Administrator. To resolve this issue, EMC recommends that you set the number of channels to no more than two times the number of processors. If the problem persists after making this change, further reduce the number of channels

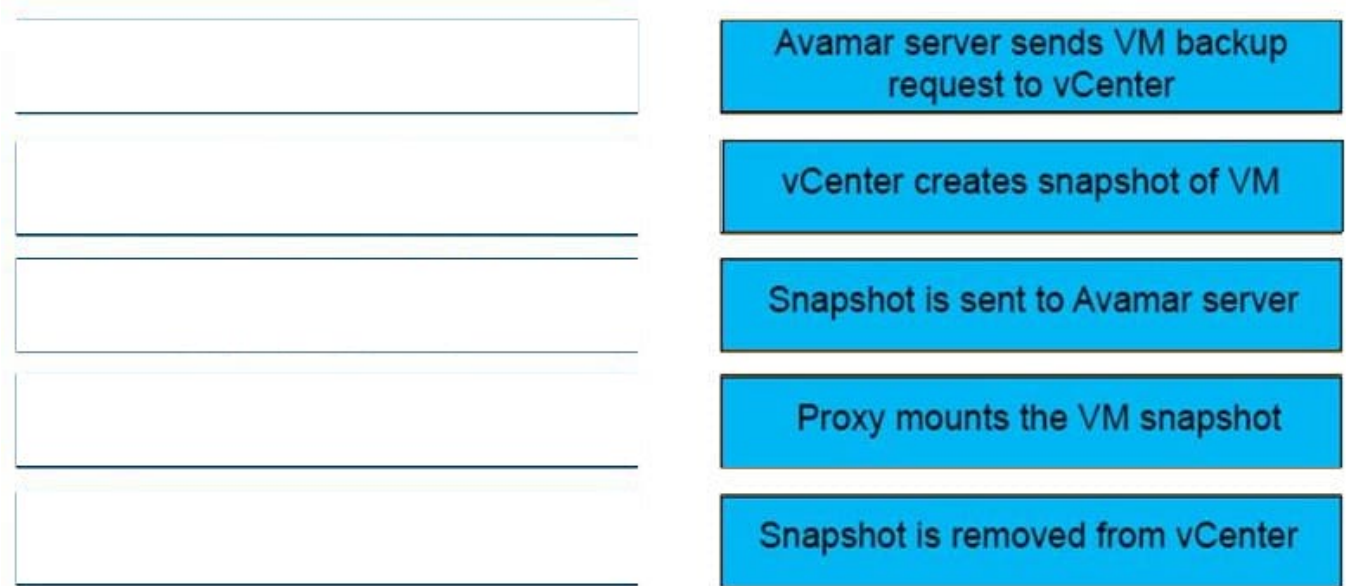

Select and Place:

vCenter creates snapshot of VM	Step 1
Snapshot is removed from vCenter	Step 2
Avamar server sends VM backup request to vCenter	Step 3
Snapshot is sent to Avamar server	Step 4
Proxy mounts the VM snapshot	Step 5
