BPM helps you align your business processes with industry-standard processes that are described by the American Productivity and Quality Center (APQC). You can perform fit-gap analysis between your business requirements and the default processes in finance and operations apps. Additionally, you can add new business processes that aren\\'t already defined.



Box 2: Segregation of duties Disallow the same employee to both post and pay invoices

The idea of Segregation of Duties (aka Separation of Duties) is that a single user should not be able to perform certain actions in a financial system by themselves without any oversight. An easy example would be that a user within an ERP should not be able to create a vendor and then pay that vendor as this could lead to fraudulent transactions. Depending on the size and risk tolerance of your organization there are many ways to avoid situations like this, you could have one user who creates the vendors and another user who pays them or in smaller departments where users have to 'wear multiple hats' you may have to assign risky access like this and then have some sort of transaction sampling or review to validate that the user did not perform those actions.
