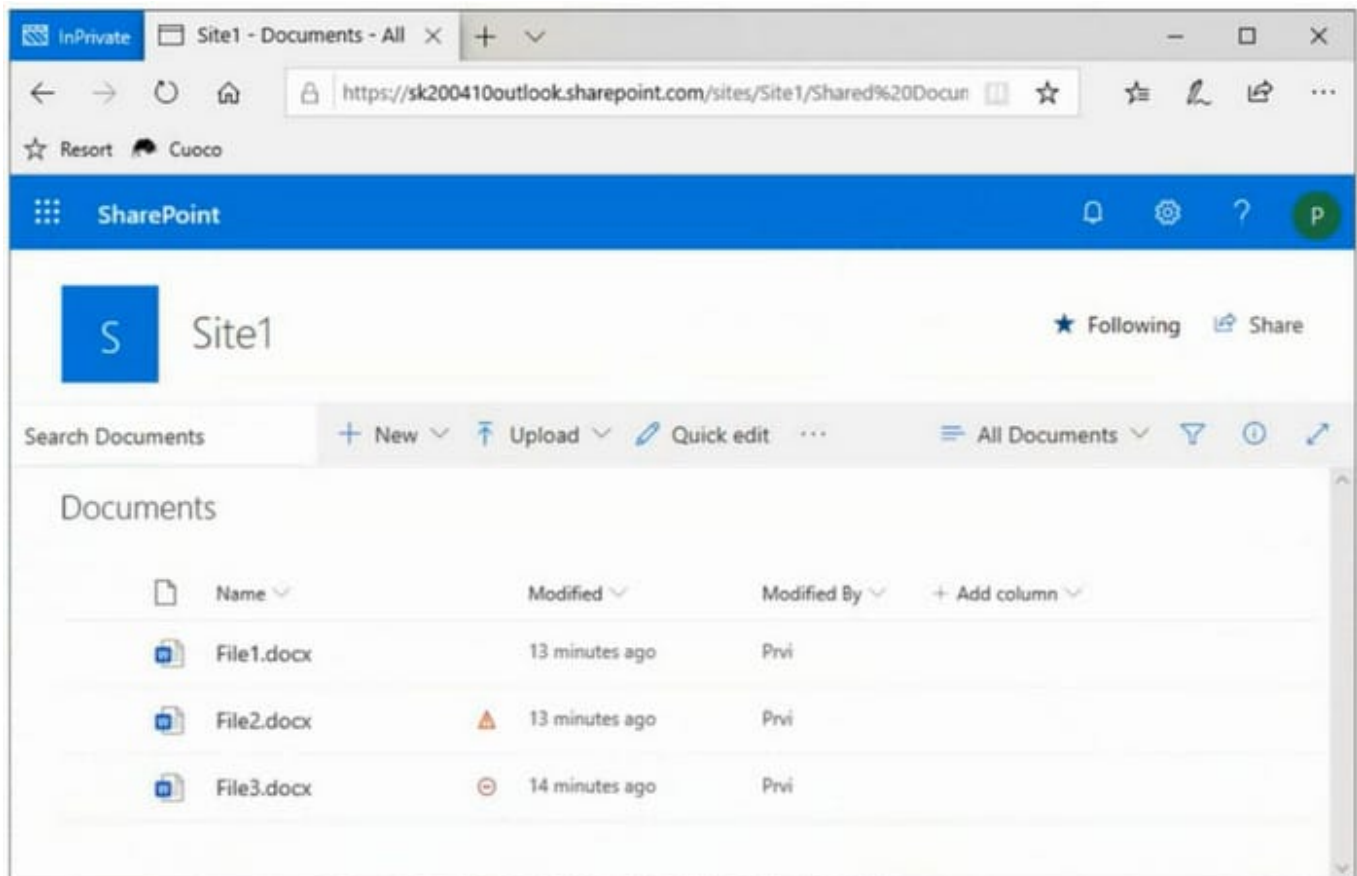

As User1 is the owner of the Site1, they have full control over the site and its contents, including the ability to apply retention labels to any file in the site. Therefore, User1 can apply Retention1 to all the files in Site1, including File1.docx, File2.docx, and File3.docx.

User2 is assigned the Member role in Site1, which gives them the ability to add, edit, and delete files in the site, as well as apply retention labels to files. Although File2.docx and File3.docx have DLP warning and blocked icons respectively, this does not prevent User2 from applying a retention label to these files. Therefore, User2 can apply Retention1 to all the files in Site1, including File1.docx, File2.docx, and File3.docx.
