QUESTION 2

Which two statements about ASM paths and file names are correct?

- A. Absolute paths must begin from the root directory of the server.
- B. Relative paths start from the Grid Infrastructure home directory.
- C. When an Oracle ASM file is created with an alias file name, you can access the file with either name.
- D. Absolute paths can access a file or directory regardless of the current directory.

Correct Answer: CD

C: Alias names, or aliases, are intended to provide a more user-friendly means of referring to Oracle ASM files, rather than using the system-generated filenames.

You can create an alias for a file when you create it in the database, or you can add an alias to an existing file using the ADD ALIAS clause of the ALTER DISKGROUP statement. You can create an alias in any system-generated or user-created Oracle ASM directory. An alias must include the disk group name; you cannot create an alias at the root level (+).

QUESTION 3

Which two options are checked by the Oracle Universal Installer, when you first install Oracle Software on a system?

- A. if the OFA-compliant path is available
- B. oraInst.loc should exist
- C. that the user running the installation has permissions to write to the designated path

Correct Answer: AB

When installing an OFA-compliant database using Oracle Universal Installer, ORACLE_BASE is set to / pm/app/oracle by default.

*

All Oracle products on CD-ROM are OFA-compliant; that is, Oracle Universal Installer places Oracle products in directory locations that follow OFA guidelines

B: Every Oracle software installation has an associated Central Inventory where the details of all the Oracle products installed on a host are registered. The Central Inventory is located in the directory that the inventory pointer file specifies. Each Oracle software installation has its own Central Inventory pointer file that is unknown to another Oracle software installation.

QUESTION 4

Correct Answer: C

You can bond separate interfaces to a common interface to provide redundancy, in case of a NIC failure, but Oracle recommends that you do not create separate interfaces for Oracle Clusterware and Oracle RAC. If you use more than one NIC for the private interconnect, then Oracle recommends that you use NIC bonding. Note that multiple private interfaces provide load balancing but not failover, unless bonded.

QUESTION 5

Correct Answer: A

srvctl modify nodeapps Options Option Description -n node_name Node name. -o clusterware_home Oracle Clusterware home for node applications such as VIP, ONS, and GSD. -A new_vip_address The node level VIP address (name|ip/netmask[/if1[|if2|...]]).

srvctl config nodeapps Option

Option Description -n node_name Node name. -a Displays the VIP address configuration. -g Displays the GSD configuration. -s Displays the ONS configuration.

Correct Answer: AB

A: In Pre-Oracle RAC 11g Release 2 we did manually changed the kernel Parameters to meet Oracle RAC minimum requirements

B: With Oracle Clusterware 11g release 2, Oracle Universal Installer (OUI) detects when the minimum requirements for an installation are not met, and creates shell scripts, called fixup scripts, to finish incomplete system configuration steps. If OUI detects an incomplete task, then it generates fixup scripts (runfixup.sh). You can run the fixup script after you click the Fix and Check Again Button.

You also can have CVU generate fixup scripts before installation. Reference: Installation Fixup Scripts

Which three types of files can be stored in Oracle ASM without extending it with ACFS?

ASM supports most file types required by the database. However, you cannot store some administrative file types on ASM disk groups. These include trace files (not E), audit files, alert logs, export files, tar files, operating system files (not F), and core files (not C).

QUESTION 8

Correct Answer: D

D: If you choose to create an Oracle grid infrastructure home manually, then do not create the Oracle grid infrastructure home for a cluster under either the grid installation owner Oracle base or the Oracle Database installation owner Oracle base. Creating an Oracle Clusterware installation in an Oracle base directory will cause succeeding Oracle installations to fail.

/ Requirements for Creating an Oracle Grid Infrastructure Home Directory



During installation, you are prompted to provide a path to a home directory to store Oracle grid infrastructure software. Ensure that the directory path you provide meets the following requirements:

*

(not a) It should be created in a path outside existing Oracle homes, including Oracle Clusterware homes.

*

It should not be located in a user home directory.

*

It should be created either as a subdirectory in a path where all files can be owned by root, or in a unique path.

*

(not C) If you create the path before installation, then it should be owned by the installation owner of Oracle grid infrastructure (typically oracle for a single installation owner for all Oracle software, or grid for role-based Oracle installation owners), and set to 775 permissions.

QUESTION 9

Which two statements are true regarding the functionality of the remap command in ASMCMD?

remap Purpose Marks a range of blocks as unusable on the disk and relocates any data allocated in that range.

*

remap Command

The remap command only relocates blocks. It does not correct or repair blocks that contain corrupted contents. The command uses a physical block size based on the disk group attribute. SECTOR_SIZE Purpose Repairs a range of physical blocks on a disk. The remap command only repairs blocks that have read disk I/O errors. It does not repair blocks that contain corrupted contents, whether or not those blocks can be read. The command assumes

a physical block size of 512 bytes and supports all allocation unit sizes (1 to 64 MB).

QUESTION 10



How many Oracle Clusterware interconnect networks are required and why?

- A. Only one; minimum requirement
- B. Two; redundancy is required

Correct Answer: C

Oracle Clusterware requires a cluster interconnect configured for inter-node communication. Note:

*

The Oracle Clusterware interconnect is a non-traditional interconnect and should be considered, in shared global cache applications, such as Oracle RAC, to be an I/O subsystem for inter-node global cache buffer transfers with the latency and bandwidth requirements of high performance cluster computing.

*

The interconnect network is a private network using a switch (or multiple switches) that only the nodes in the cluster can access. And Oracle Clusterware requires that you connect the nodes in the cluster to a private network by way of a private interconnect. The private interconnect is a separate network that you configure between cluster nodes. The interconnect used by

Oracle RAC is the same interconnect that Oracle Clusterware uses. This interconnect should be a private interconnect, meaning it is not accessible to nodes that are not members of the cluster. Reference: Oracle Real Application Clusters (RAC) and Oracle Clusterware Interconnect Virtual Local Area Networks (VLANs) Deployment Considerations

QUESTION 11

Which command can be used to modify and configure voting files?

Correct Answer: B

Add a voting disk, as follows:

$ crsctl add css votedisk path_to_voting_disk
```

The CRSCTL and ocrconfig commands enable the placement of OCR storage and Cluster Synchronization Services (CSS) voting files inside the disk groups managed by Oracle ASM.

QUESTION 12

Correct Answer: A

*

Block or raw devices are not supported by Oracle Universal Installer (OUI) or Database Configuration Assistant (DBCA). However, manually configured raw or block devices are supported by Oracle, but not recommended.

*

Shared disk access requires some sort of networked storage iSCSI (not D)

Fibre Channel/SCSI

NFS (not B)

*

A logical volume is supported in less complicated configurations where a logical volume is mapped to a LUN, or a logical volume uses disks or raw partitions.
