

# **QUESTION 3**

Which type of variable must be declared before it is used in a trigger?

- Correct Answer: A

PL/SQL is the language used in Forms triggers and program units.

PL/SQL lets you declare variables and constants, then use them in SQL and procedural statements anywhere an expression can be used. You must declare a constant or variable before referencing it in any other statements.

Variables can have any SQL datatype, such as CHAR, DATE, or NUMBER, or a PL/SQL-only datatype, such as BOOLEAN orPLS\_INTEGER.



#### Note:

PL/SQL\\'s data types correspond with SQL\\'s column types, making it easy to interchange PL/SQL variables with data inside a table.

#### **QUESTION 4**

You have just created radio buttons labeled Outstanding, Exceeds, Meets, and Does not Meet for the employee appraisal rating, but you accidentally created it on the Employee\_Training canvas rather than on the Employee\_Appraisal canvas. How can you move them to the appropriate canvas?

Once you return back to the Layout Editor, you have to insert radio buttons. Select Radio Button icon from the toolbox. Drop the radio button into the form.

A window will appear, prompting you to select the radio group you would liketo attach this radio button to. Select the radio group Sex .



#### **QUESTION 5**

A: Including a block in an object group also includes its items, the item-level triggers, the block- level triggers and the relations

Note: An object group is a logical container for a set of Forms Builder objects. You need to define an object group when you want to package related objects for copying or subclassing in another module or if you want to bundle numerous objects into higher-level building blocks that you can use again in another application. You can package the various objects in an object group and copy the entire bundle in one operation.

# **QUESTION 6**

You have been assigned to maintain a forms application that was designed by a developer who has left the company.

The form uses different property classes to standardize the appearance of objects in the form. For example, all buttons should be of the same width.

The CV\_Tools canvas contains several buttons. The Print invoice button is not quite wide enough to display its complete label.

In forms Builder, you open the Button\_PC property class and change its Width property to a higher number. All the buttons become larger except the Print invoice button, which remains its original size. What could have caused this problem?

#### **QUESTION 7**



B: Order\_Items is a detail block.

C (not F): A master block record cannot be deleted if there are corresponding detail block records.

D: To delete an order, all the corresponding order items must be deleted, for example through an ONCHECK-DELETE-MASTER trigger.

G: The Orders block is a master block.

Incorrect answers:

E: Order\_items can very well be deleted without deleting the corresponding order.

J: There are no triggers for INVENTORIES.

Either Master or Detail Triggers would have been created if it was either a Master or Detail block.

Note: Master/Detail Triggers: Oracle Forms generates master/detail triggers automatically when a master/detail relation is defined between blocks. The default master/detail triggers enforce coordination between records in a detail block and the master record in a master block. Unless developing custom block- coordination schemes, you do not need to define these triggers.

\*

On-Check-Delete-Master Fires when Oracle Forms attempts to delete a record in a block that is a master block in a master/detail relation.

\*

On-Clear-Details Fires when Oracle Forms needs to clear records in a block that is a detail block in a master/detail relation because those records no longer correspond to the current record in the master block.

\*

On-Populate-Details Fires when Oracle Forms needs to fetch records into a block that is the detail block in a master/detail relation so that detail records are synchronized with the current record in the master block.

#### **QUESTION 10**

Users do not want to see the "Working" message while a long query completes.

You are designing a form with a query that takes o long time to execute. What can you do to stop the "Working" message from appearing?

database trigger that fires before the update of Customer\_Id:

The SQLERRM function returns the error message associated with the most recently raised error

exception.

Note: The RAISE\_APPLICATION\_ERROR procedure lets you issue user-defined ORA-n error messages

from stored subprograms. That way, you can report errors to your application and avoid returning

unhandled exceptions.

To invoke RAISE\_APPLICATION\_ERROR, use the following syntax:

raise\_application\_error(

error\_number, message[, {TRUE | FALSE}]);

where error\_number is a negative integer in the range -20000..-20999 and message is a character string

up to 2048 bytes long. If the optional third parameter is TRUE, the error is placed on the stack of previous

errors. If the parameter is FALSE (the default), the error replaces all previous errors.



You can associate the toolbar canvas with the window shared by the content canvases, and it will display. The location at which the toolbar displays can be controlled by the type of toolbar canvas used. A vertical toolbar canvas is used to display the toolbar along the left or right edge of the window.
