A dynamic disk is a physical disk, which supports volumes that span multiple disks such as striped volume, RAID-5 volume, etc. A dynamic disk uses a hidden database to track information about dynamic volumes on the disk and other

dynamic disks in the computer. Dynamic disks can be made by converting the basic disks. This can be done by using Disk Management or the DISKPART command-line utility. When a basic disk is converted into a dynamic disk, all existing

basic volumes become dynamic volumes.

It can also be used to terminate processes and programs, as well as change the processes priority. The task manager is most commonly accessed by pressing the buttons Control-Alt-Delete. Task manager also displays all the services that are currently running as well as those that were stopped. All information\ about the services such as Process ID and their group if they are applicable.

B: Performance Monitor is a Windows tool that monitors system and network resources. It is used to get statistical data about hardware and software components of a server.

D: Resource Monitor is a suite of administration tools designed to provide a quick overview of a single user interface. It acts as a mediator between the Cluster service and the resource dynamic link library. It can be launched from the start menu or from the Task Manager using the Performance tab. Resource Monitor can be accessed by searching in the Reliability and Performance monitor.
