What does "At Risk" mean in the Operations Center? The Operations Center considers recent activity for a client and determines whether the client is at risk of being unprotected. The "at risk" designation primarily indicates that an administrator should investigate a client issue to determine whether or not it creates a significant risk (based on the business goals, data protection strategy, and such).

The "at risk" processing considers clients that are automated using TSM scheduling.

QUESTION 2

What is meant by the archive option, RETVER=365?

- A. Retain archive data for 365 days.
- B. Retain 365 archive versions of this file.
- C. Retain 365 backup versions of this file.

D. Migrate the file back to the customer\\'s server after 365 days.

Correct Answer: A

You can control the period for which migration copies are stored in Tivoli Storage Manager storage. If you accept the installed-default data management policy, migration copies can be deleted from Tivoli Storage Manager storage in one year.

RETVer determines the number of days to retain a migration copy. When the retention period specified by RETVer ends, the Tivoli Storage Manager server marks the file for deletion.

The Backup Operators group allows users to back up and restore files regardless of whether they have read or write access to the files. Since this group has a limited set of user rights, some functions are not available to members of the Backup Operators group.

Not A: IBM Tivoli Storage Manager is a client and server program that provides storage management solutions to customers in a multi-vendor computer environment. IBM Tivoli Storage Manager provides an automated, centrally scheduled,

policy-managed backup, archive, and space-management facility for file servers and workstations. Not D: No such thing as an Integrated Storage Console.

The backup feature keeps and maintains versions of backup data whereas the archive feature retains a long term copy of data without storing or maintaining versions.

A client is considered to be at risk if a problem occurs during its most recent scheduled backup, or during a backup that starts within a specified time interval. The term backup also includes archive operations for Tivoli Storage Manager for

Enterprise Resource Planning clients. Use the information that is shown in the TSM Clients section to check for failed or missed backups and to determine whether backup schedules are running as expected.

QUESTION 10

What is left on the client disk when a file is migrated using IBM Tivoli Storage Manager space management?

- Correct Answer: B

When a file is migrated from your local system to Tivoli Storage Manager storage, a placeholder, or stub file, is created in place of the original file. Stub files contain the necessary information to recall your migrated files and remain on your local file system so that the files appear to reside locally. This contrasts with archiving, where you usually delete files from your local file system after archiving them.



QUESTION 11

What occurs in the IBM Tivoli Storage Manager (TSM) Operations Center V7.1 when the command set status skip as failure off type=vm is set in the TSM server?

set statusskipasfailure off type=vm

Note: SET STATUSSKIPASFAILURE (Specifies whether to use client at-risk skipped files as failure evaluation)

Use this command to enable the status monitor to consider clients as at risk when evaluating the status for each client.

QUESTION 12

What is the purpose of the client acceptor daemon?

The client acceptor daemon serves as an external timer for the scheduler. When the scheduler is started, it queries the server for the next scheduled event. The event is either executed immediately or the scheduler exits. The client acceptor daemon restarts the scheduler when it is time to execute the scheduled event.
