account. For example, to split a ledger account into two levels, you can use the account number format xxxx-yy. Here, the first four characters denote the first level, such as a cash account, and the last two characters denote the second level,

such as a cash account in a different currency.

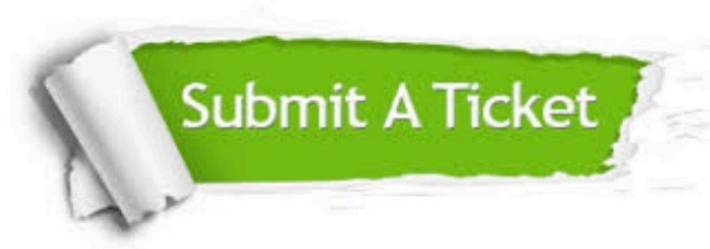
